The goal of the Animal Safe Home Network (ASHN) is to provide temporary, emergency shelter for the pets of victims of domestic violence.

You can help a victim of domestic violence by becoming a "foster parent" to an animal.

According to studies, 18% to 40% of women seeking shelter at a crisis center report concern for their pets' welfare prevented them from seeking shelter sooner, in some cases, as long as two months or more.

When violence strikes a family, each member of that family, including any companion animal in the home, is a victim.
